It was moved by Commissioner Troy Bassett and was seconded by Commissioner Allan Ott to approve the Schoolcraft Medical Care Facility Millage Renewal Language for the November 8, 2022, ballot as follows:

SCHOOLCRAFT COUNTY MEDICAL CARE FACILITY MILLAGE RENEWAL PROPOSAL

Shall the previous voted increase in the limitation of the amount of property taxes that may be assessed each year against all taxable real and personal property in Schoolcraft County of 1.50 mills (S 1.50 per \$1,000 of taxable value) be renewed at up to a maximum of 1.5 mills (\$1.50 per \$1000 of taxable value) for a period of ten (10) years, 2023 through 2032, inclusive, to provide funds for operation and maintenance of the Schoolcraft County Medical Care Facility and shall Schoolcraft County levy the millage for this purpose thereby raising an estimated \$556,346.86 (based on the 2021 tax rate) in the first year of the levy? The proposed millage is a renewal of a previously authorized millage.

The motion carried by a unanimous aye vote of the Board members present.

Commissioner Paul Walker addressed the Emergency Manager Contract with Delta County is up the end of September and Delta County has opted to not renew the contract with Schoolcraft County. He will keep the Board informed of this situation.

It was moved by Commissioner Allan Ott and was seconded by Commissioner Troy Bassett to approve the MDOT Airport Block Grant, Contract No. 2022-0796, (5% match of local funds), the FAA Certification and Disclosure forms 5100-135, 5100-130, 5100-134, and authorize Paul Walker, Board Chair, to sign said documents. The motion carried by a unanimous aye vote of the Board members present.

It was moved by Commissioner Paul Walker and was seconded by Commissioner Allan Ott to approve the Childcare Fund Grant Application, in the amount of \$219,427.44 and authorize Paul Walker, Board Chair, to sign said application. The motion carried by a unanimous aye vote of the Board members present.

It was moved by Commissioner Troy Bassett and was seconded by Commissioner Allan Ott to approve the Legal Representation Grant Application in the amount of \$10,500. The motion carried by a unanimous aye vote of the Board members present.

It was moved by Commissioner Paul Walker and was seconded by Commissioner Allan Ott to approve the Raise the Age Grant application in the amount of \$50,000. The motion carried by a unanimous aye vote of the Board members present.

It was moved by Commissioner Troy Bassett and was seconded by Commissioner Alan Kilar to approve the Crime Victims Rights Grant Application in the amount of \$12,488. The motion carried by a unanimous aye vote of the Board members present.
